## **Wallace Figure Skating Club Financial Obligation**

**\*\*\*\*\* Please read carefully, changes have been made \*\*\*\*\***

- All accounts with Wallace Figure Skating Club must be current. Sessions will not be booked for skaters with past-due accounts. Participation in the annual show will not be allowed with past-due accounts.
- Returned checks will be charged \$20.00. This charge must be paid prior to more sessions being booked and/or participation in the annual show. WFSC will not accept postdated checks at any time.
- Make-ups must be used in the current session. All Make-ups are valid only for the session for which they were issued.
- You are contracting with the Wallace Figure Skating Club for Ice and/or Ice and Coaching time. The amount is due for each amount contracted. Options cannot be cancelled. Exceptions are medical and death. Release from a contract for a medical exception is submitted to the WFSC Board of Directors for review.
- All balances must be paid 7 days prior to costume distribution to avoid confusion. If your account is not current you will not receive your costume, and/or be allowed to participate in the annual show. No Personal checks after February 28<sup>th</sup>, balances must be paid by cash, bank check or money order.
